



## Westminster Abbey Muniments 1912

Declaration of the lands and tenements in Ewell (Co. Surr.) held by Richard Vynes of the Abbat, Prior and Convent of Westminster.

*Ewelle : Declaratio terrae et tentorum ibidem voc [ ?Ewydp.....] /*  
**Ewell: Declaration of lands and holdings there called .....**

*Ricardus Vynes in jure Elizabeth uxoris eius relict Johanni Codyngton filii et heredis Thoma de Codynton (1)/*  
**Richard Vynes in right of Elizabeth his wife, widow of John Codyngton, son and heir of Thomas de Codynton, [holds]**

*libere ibidem de dictis Abbatis, priori et convento ut de maneria suo de Morden in dicto comito de Surrey, unum mesuagium [.....] (2)/*  
**freely there from the said Abbot, prior and convent, as of their manor of Morden in the said county of Surrey, one messuage [with]**

*que quondam fuerit Gaufrid le Cras postea Thoma de sancti Michaelis postea Laurentius Codington postea Thoma Codyngton, postea . . .*  
**that once was of Geoffrey le Cras afterwards Thomas de Saint Michael, afterwards Laurence Codyngton afterwards Thomas Codyngton, afterwards ...**

*pertin iacet in Ewell predicto iuxta tenementum modo Ricardi Skete et nuper Johanni Cosyn ^ videlicet aulam camera [ ...] (3)/*  
**pertinents lying in Ewell aforesaid, next to the tenement now of Richard Skete and formerly of John Cosyn, ^ namely the hall, chamber ...**


*portam cum cameris ex utraque parte portam praedictam, exceptus stabulus iuxta tenementum predictum dicti Ricardi Skete et nuper Johanni [ . . . ] (4)/*  
**gate with a chamber on each side of the aforesaid gate, excepting the stable next to the aforesaid tenement of the said Richard Skete and formerly of John**

*Cosyn in parte boriali dicti tenemento situate et contineo in latitudine vii pedes et cum parcella clausura tenementum dicti Ricardi (5)/*  
**Cosyn, situated on the north of the said tenement and containing in breadth seven feet, and with part of a close of the tenement of the said Richard,**

*et nuper dicti Th. de Codyngton contineo in longitudino xl pedes iuxta tenementum dicti Ricardi Skete et nuper Johanni Cosyn (6)/*  
**and formerly of the said Thomas de Codyngton, containing in length forty feet next to the tenement of the said Richard Skete and formerly of John Cosyn,**

*tenet de priore de Merton etc. (7)/*  
**he holds from the prior of Merton etc.**

*Idem Ricardus Vynes in jure Elizabeth uxoris eius predicti tenet de predictis Abbatie et convento unum aliud mesuagium cum (8)/  
The same Richard Vynes in right of Elizabeth his wife aforesaid holds from the aforesaid Abbot and convent, one other messuage with*

*predicto Laurentius Codyngton  
the aforesaid Laurence Codyngton,*

*suis pertinens in Ewelle que quondam sint Walteri Snell postea Thomae de sancti Michaelis postea ^ Thomae (9)/  
its pertinents in Ewell that once was of Walter Snell afterwards Thomas de Saint Michael afterwards ^ Thomas*

*Codyngton et postea Ricardi Benton. Et debet sectationem ad curia de Morden herietum et relevium et facit [...] (10)/  
Codynton and afterwards Richard Benton. And he owes suit at the court of Morden, heriot and relief. And he does ...*

*diversis opera sicut apparet in custuma de Domesday et domus mesuagii iacet ex opposito mesuagio in quo d[icitur] [...] (11)/  
various works just as they appear in the custumal of Domesday and the house of the messuage lies opposite the messuage in which the [said Richard]*


*inhabit[at] et una venella separata ambo mesuagia predicta. (12)/  
dwells, and one lane separates both the messuages aforesaid.*

*Idem Ricardus tenet de dictis Abbatie, priore et convento 1 acris terrae nuper dicti Th. de Codyngton iacet in le N[orth]-J(13)/  
The same Richard holds from the said Abbot, prior and Convent, 1 acre of land, formerly of the said Thomas de Codyngton, lying in the N[orth]*

*crofta a Frelondesherne per spatum ii acrae et dimidii ex parte boriali et Ricardesfeld ex parte occidentali et le [...] (14)/  
croft from Frelondesherne by a distance of two and half acres on the north part and Ricardesfeld on the west part and the ...*

*Fotepath quo ducto de Ewell versus Kyngston ad aliud caput et dimidium acram terram modo Willelmi M[...] (15)/  
Footpath which leads from Ewell to Kingston at the other headland and a half acre of land now of William M[erston]*

*Armiger et nuper Johanno Ferby ex parte altera. (16)/  
esquire and formerly of John Ferby on the other part.*




*Idem Ricardus tenet de dictis Abbatie et convento in predicto Northcroft quatuor acres terrae simul iacet que nuper fuerit (17)/  
The same Richard holds from the said Abbot and convent in the aforesaid Northcroft, four acres of land together lying that formerly were*

*dicti Thoma de Cuddynton inter Muggelespole ex parte una et terram vocat le Mersshdyke ex parte (18)/  
of the said Thomas de Cuddynton between Muggelespole on the one part and the land called the Mersshdyke on the other part*

*altera et dimidium acrae modo Willelmi Exham et nuper Th Cynore ex parte australi et terrae modo Johanni (19)/  
and a half acre now of William Exham and formerly of Thomas Cynore on the southern part and the lands now of John*

*Sandon et nuper Th. Smyth ex parte boriali etcetera. (20)/  
Sandon and formerly of Thomas Smyth on the north part etc.*

*Idem Ricardus tenet de predictis Abbatii et convento in dicto campo de Northcroft ii acram terrae que nuper fuerit (21)/*  
The same Richard holds from the aforesaid Abbot and convent in the said field of Northcroft, two acres of land which formerly were

*dicti Th de Codyngton et iacent iuxta terram Willelmi Merston armiger et nuper Walteri Whitelok ex (22)/*  
of the said Thomas de Codyngton and lie next to the land of William Merston esq and formerly of Walter Whitlok on

*parte boreali et terram Johannis Exham ex parte australi et Ewelbroke ad caput orientale (23)/*  
the northern part and land of John Exham on the southern part and Ewelbroke at the east headland.

*Idem Ricardus tenet de ipsis Abbati et convento in Lyngcroft, iij acrae terrae que nuper fuerunt dicti Th. de (24)/*  
The same Richard, holds from the Abbot and convent themselves in Lyngcroft, four acres of land which formerly were of the said Thomas de

*Codyngton et iacent iuxta viam regiam vocat Galwstrete que ductum de Ewelle versus Epysham (25)/*  
Codyngton and they lie next to the royal road called Gallowstrete {=West Street} that leads from Ewell to Epysham {Epsom}

*et terra Johanni Exham quondam Th. Hayton ex parte orientale et dicti Johanni Exham quondam Johanni (26)/*  
and land of John Exham, once of Thomas Hayton on the east part and of the said John Exham once of John

*Kyppyn ex parte boriale et dictae terrae sint de feodo abbatis Westmonasterii et terra modo Johanni Tregeleston (27)/*  
Kyppyn on the north part and the said lands are of the fee of the Abbot of Westminster and the land now of John Tregeleston

*et nuper Johanni Hochon in jure uxore eius ex parte occidentali (28)/*  
and formerly of John Hochon in right of his wife on the west part.

*Idem Ricardus tenet de dictis Abbatii et convento iij acras terrae nuper dicti Th de Codyngton et iacent (29)/*  
The same Richard holds from the said abbot and convent three acres of land formerly of the said Thomas de Codyngton and they lie

*in uno furlongo vocat Colleshegge et abuttat ad caput orientali super regiam viam quo dicit (30)/*  
in one furlong called Colleshegge and abut at the east headland upon the royal road which leads

*de Ewell versus Epysham et inter dimidium acrae terrae modo Johanni Ovyngton et nuper W Bole ex parte australi (31)/*  
from Ewell to Epsom and between/among a half acre of land now of John Ovyngton and formerly of W Bole on the southern part.\*


*Idem Ricardus tenet de predictis Abbatii et convento iij acrae terrae vocat Thomasdene nuper dicti Th de Codyngton (32)/*  
The same Richard holds from the aforesaid abbot and convent, three acres of land called Thomasdene formerly of the said Thomas de Codyngton

*iacet extransverso viam regiam quo dicit de Ewell versus Epysham ex parte orientale et terra (33)/*  
lying across the royal road that leads from Ewell to Epsom on the east part and the land of

*abbatis de Chertsey ex partibus borialis et occidentalis (34)/*  
the Abbot of Chertsey on the north and west parts.

\* The half acre may have been divided into strips separating Richard's three acres.

*Idem Ricardus tenet de predictis Abbatis et convento ix acras terrae nuper predicti Th de Cuddyngton et iacent (35)/*  
The same Richard holds from the aforesaid Abbot and convent, nine acres of land formerly of the aforesaid Thomas de Cuddyngton and they lie

*in simul apud Longdowns et abuttat ad caput occidentale super unum furlongum vocat Clotedon et (36)/*  
together at Longdowns and abut at the west headland upon one furlong called Clotedon and

*dicti ix acrae terrae iacent inter unam acram terrae Willelmi Merston Armiger ex parte australi et aliam acram terrae (37)/*  
the said nine acres of land lie between one acre of land of William Merston esquire on the southern part and another acre of land

*eiusdem Willelmi ex parte boriali (38)/*  
of the same William on the northern part.

*Idem Ricardus tenet de dictis Abbatis et convento ix acras terrae que nuper fuerunt Johanni Leversage postea (39)/*  
The same Richard holds of the said Abbot and convent nine acres of land that were formerly of John Leversage afterwards

*Johanni Edwardby de Recepta domini Regis et postea in tenur' Ricardi Benton et iacent coniunctim (40)/*  
John Edwardby, of the Receipts of the lord king, and afterwards in the tenure of Richard Benton and they lie together

*apud Albregge in quodam crofto vocat Lyngcroft et dicti ix acrae vocant Robetteslond et iacent (41)/*  
at Albregge in a certain croft called Lyngcroft and the said nine acres are called Robertesland and they lie

*iuxta viam regiam que dicit de Ewell versus Communiam prioris de Merton in Ewell et abuttat (42)/*  
next to the royal road which leads from Ewell to the Common of the Prior of Merton in Ewell and abut

*ad terras nuper Th de Codyngton et modo dicti Ricardi Vynes ex parte occidentali et ad terram Thoma (43)/*  
to the lands formerly of Thomas de Codyngton and now of the said Richard Vynes on the west part and to the land of Thomas

*Smyth ex parte orientali. (44)/*  
Smyth on the east part.

### NOTES:

A contemporary description of the vill and fields of Ewell in 1408 lists these and other holdings of Laurence de Cuddington in Ewell, though many are not attributed to Mordensfee.
