- BURY-HILL-PARK, in the parish of Dorking, 1<sup>1</sup>/<sub>4</sub> miles W. S.W. from that town, and 24 S. S.W. from London; a handsome modern mansion, with extensive plantations and pleasure grounds, and a beautiful lawn, with a gentle descent to the edge of a fine sheet of water, the seat of *Robert Barclay*, *Esq*.
- BUSBRIDGE-HALL, in the parish of Godalming, 14 mile south from that town, and 35 S. S.W. from London; an elegant and extensive modern mansion, pleasantly situated in a valley in an extensive park, which is beautifully laid out and ornamented with fine trees, shrubberies, a grotto, lake, cascade, gardens, &c. &c. being a most delightful retired situation, the seat of *H. H. Townsend*, *Esq.*
- BUSH-HOUSE, a farm in the parish of Horley, 3<sup>1</sup>/<sub>2</sub> miles S. from Reigate.
- BUSY-ONE'S-FARM, a farm in the parish of Chiddingfold, 6½ miles S. from Godalming.
- BUTCHERS-POND-FARM, a farm in the hamlet of Ripley and parish of Send, 5 miles N.N.E. from Guildford.
- BYES-FARM, a farm in the parish of Nutfield, 2<sup>1</sup>/<sub>2</sub> miles E. from Reigate.
- BYFLEET, a parish in the hundred of Godley and Chertsey, near the Wey, 2 miles W. N.W. from Cobham, and 22 S.W. from London; containing, in 1801, 67 houses, and 362 inhabitants. Population in 1811, 392; in 1821, 427. There wasformerly a royal palace in this place, and at Dorney-House King Henry the Eighth

was nursed. The living is a rectory, value 9l. 11s. 8d., patron, the King; incumbent, Rev. George Sewell. Besides West-Lodge, there are here the residences of *Mr. Bowyer*, and *Miss Shapnell*.

- BYFLEET-PARK, in the parish of Byfleet, probably formerly annexed to the royal palace, is now a very extensive farm, with a good house, the residence of *Mr*. *Langton*.
- BYSHE-COURT, in the parish of Horne, 6 miles S.W. from Godstone; an extensive farm, with an excellent house, the present residence of *Mr. William Rhodes*, the property of ——— of London.

- CÆSAR'S-CAMP, the site of a Roman encampment, on Hungry-hill, at the northern extremity of the parish of Farnham, adjoining to Hampshire.
- CAMBERWELL, a parish in the hundred of Brixton, 2½ miles S.S.E. from London-bridge; containing, by the census of 1811, 1939 houses, and 11,309 inhabitants, including the hamlets of Dulwich and Peckham; and by the census of 1821, 17,876 inhabitants. The living is a vicarage, value 20*l.*, patron J. Windham, Esq.; incumbent, the Rev. Edward Smith. The church is an ancient building of stone. In the middle of Camberwell is the Green, surrounded with good houses and shops; and here is held a fair on the 18th of August, numerously attended by the Londoners. This place has been considerably improved of late years by numerous modern buildings in the neighbourhood, for the residence of

the families of tradesmen of the metropolis, with which this joins by a regular continuation of building : many houses, erected as country houses, have not that advantage; on the little beautiful eminences, however, and on some sides of this place, there are many delightful villas perfectly rural, and the neighbourhood airy, and very pleasant, having a variety of little hills and vales; and a full display of taste in the erection of buildings and laying out of pleasure grounds; and though the side towards town has in part lost the appearance of being rural, it has attracted persons of high respectability. To enumerate all the numerous residents here in a work like the present, would be inappropriate to its design, which is to point out and describe the principal residences. Many must necessarily be omitted on so near an approach to town; and all those which have become joined as streets, (not distinguished by names,) are omitted; such are all those southward from the Green. Camberwell-Grove has a beautiful embowered walk, and contains, amongst its residences, those of John Walton, Esq., John Perry, Esq., Charles Dodd, Esq., Nathaniel Hardcastle, Esq., --- Richardson, Esq., A. Hardcastle, Esq., --- Wallis, Esq., and --- Grey, Esq. -In Grove-Crescent, John Luke, Esg., Mrs. Webster, Mr. Stanfield, Mrs. Eade, Robert Preston, Esg., John Davis, Esq., --- Liddard, Esq., Samuel Fable, Esq.; and at Thatched-cottage, Robert Chapman, Esq ..-Grove-lane, Enis Maddox, Esq., the Misses Powell, Robert Rawson, Esq., Captain Hilton, Miss Childs, William Morgan, Esq., William Woodbridge, Esq., Samuel Carter, Esq., and John Turner, Esq.- Grove-hill, William Wynn, Esq., Jacob Wrench, Esq., and John Horner, Esq.-Park-place, Mrs. Cullen, Charles Tottie. Esq., Rev. — Staple, Charles Fortinea, Esq., — Watson, Esq., --- Bedford, Esq., --- Foss, Esq., ---- Carter, Esq., Miss Crapper, Misses Stranger, - Smith, Esq., Mrs. Spence. - CAMILLA-LACY, a neat mansion and handsome grounds, pleasantly situated in the parish of Mickleham, 2 miles N.N.E. from Dorking, and 21 S.S.W. from London, between Denbighs and Norbury-Park, in a neighbourhood abounding with elegant seats and beautiful scenery, The seat of *Thomas Hudson*, *Esq.* a Magistrate.
- CANBURY, in the parish and adjoining to the town of Kingston, 12 miles S.W. from London-bridge, formerly a stately mansion, called Canbury-house, which has been

pulled down, now modern mansions; the residences of *Edward Kent*, *Esq.*, and *Mrs. Jeyes*. At Canbury is also an elegant mansion, the seat of *Lady Lisle*, a maid of honour to the late Queen.

- CAN-HATCH, an elegant house, in the parish of Banstead, 4 miles E. N. E. from Epsom, and 15 S. S.W. from London; near the roads from London through Sutton to Brighton and Guildford, in a neighbourhood abounding with elegant villas, the seat of Major — Haworth.
- CANHATCH-FARM, a farm in the parish of Banstead, 3 miles S. E. from Epsom.
- CANNON-FARM, a farm in the parish of Banstead, 3<sup>1</sup>/<sub>2</sub> miles S. E. from Epsom.
- CANNON-HILL, in the parish of Merton, 9<sup>1</sup>/<sub>2</sub> miles S.S.W. from London-bridge; a handsome house, the residence of *Thomas Sherwood*, *Esq*.

CAPEL, a parish in the hundred of Wooton, on the road from Dorking to Brighton, 5½ miles S. from Dorking, and 29 S. S.W. from London; containing, as per census of 1811, 105 houses, and 730 inhabitants; and as per census of 1821, 876 inhabitants. It is recorded, that in the reign of Queen Elizabeth part of a hill here, probably Leith-hill, was divided from the other part, and moved for some distance. It is a perpetual curacy, not in charge; patron, the Duke of Norfolk; incumbent, Rev. P. B. Beath. This is a farming district, a part of the wilds or wealds of Surrey adjoining to Sussex, principally producing corn; there are extensive woodlands.

CARSHALTON, alias CASEHORTON, a parish in the hundred of Wallington, 23 miles W. from Croydon, and 11 S.S.W. from London-bridge; containing, by the census of 1811, 277 houses, and 1532 inhabitants; and by the census of 1821, 1775 inhabitants. The living is a vicarage, value 111. 12s. 6d., patron, J. Rose, Esq.; incumbent, the Rev. William Rose. This beautiful village is situated amongst springs, which form first a sheet of water in its centre, surrounded by beautiful rural scenery in shrubberies and pleasure grounds; and, joining those from Beddington and Croydon, afterwards the River Wandle. There are a number of elegant seats in its vicinity; and amongst the residences in this parish, besides those mentioned under their respective appellations, are those of John Taylor, Esq., E. T. Beynon, Esq., W. Rowlett, Esq., John Ross, Esq., Rev. William Rose, rector of Carshalton (rectory), Jonas Crossingham, Esq. (the property of John Taylor, Esq.,) Robert Houstown, Esq., Jacob Foster Reynolds, Esq., John Crossingham, Esq., and Robert Burra, Esq.

- CARSHALTON-HOUSE, an extensive ancient elegant mansion, with beautiful grounds, in which are a canal and waterworks, from which all parts of the house are well supplied; adjoining to the pleasant village of Carshalton, forming a principal feature in the beautiful scenery for which this village is noted; the seat of *William Foster Reynolds, Esq.*
- CARSHALTON-PARK, in the parish of Carshalton, 11 miles S. S.W. from London, an elegant mansion and a park, adding to the beauty of this pleasant village; the seat of John Taylor, Esq.

CART-HOUSE-FARM, a farm in the parish of Little-Bookham, 3 miles W. N.W. from Dorking.

- CASTLE-FARM, a farm in the parish of Leigh, near Leigh-place, 2<sup>1</sup>/<sub>2</sub> miles W. S.W. from Reigate.
- CASTLE-HOUSE, in the parish of, and near to Streatham, 54 miles S. from London-bridge; an elegant mansion, the seat of *Henry John Rucker*, *Esq*.

CASTLE-HILL, near Betchworth-castle, in the parish of Dorking; a handsome house, with a mill and farm, the residence of *Mr. Dewdney*, 1 mile E. of Dorking.

- CATERHAM, a parish in the hundred of Tandridge,  $7\frac{1}{2}$ miles S. from Croydon, and  $17\frac{1}{2}$  S. from London; containing, according to the census of 1811, 82 houses, and 333 inhabitants; and according to the census of 1821, 435 inhabitants. The church stands on an eminence, from whence are extensive prospects. The living is a vicarage, value 8*l*. 0*s*.  $1\frac{1}{2}d$ . in the patronage of T. Hodgkin, Esq.; incumbent, Rev. Charles Hodgkin. This parish is in a high situation, on the chain of hills north of Holmesdale; an arid, chalky soil, producing corn, and turnips for cattle.
- CATERHAM-COURT-FARM, an extensive farm in the parish of Caterham, 7 miles S. from Croydon.
- CATERHAM-COURT-LODGE, a farm in the parish of Caterham, with a handsome modern house, plantations, &c., the property and villa residence of *Charles Day*, *Esq*.

- CATERHAM-MANOR-COTTAGE, in the parish of Caterham; a neat modern erection, the property of *Thomas Clarke, Esq.* lord of the manor of Caterham.
- CATSFIELD, on the west side of the town of Dorking, near San-place; a handsome house, the residence of *Mr. Crafts.*
- CEDAR-HOUSE, a spacious dwelling-house, with gardens and plantations, pleasantly situated, in the parish of Putney (on the lower road from Putney to Wandsworth), fronting the River Thames,  $6\frac{3}{4}$  miles S.W. from London-bridge, the residence of — Ackers, Esq.
- CHALDON, a parish in the hundred of Wallington, 5 miles N.E. from Reigate,  $6\frac{1}{2}$  S. from Croydon, and  $16\frac{1}{2}$ S. from London; containing, by the census of 1811, 16 houses, and 155 inhabitants; and by the census of 1821, 166 inhabitants. It is a rectory, value 7*l*. 10s.  $7\frac{1}{2}d$ ; patron, Robert Welton, Esq.; incumbent, Rev.T. Welton. This parish is in a high situation, on the chain of hills on the south of Holmesdale; a chalky soil, the land chiefly arable, and here sheep are fed on turnips.
- CHAMPION-HILL, a pleasant eminence between Camberwell and Dulwich, <sup>4</sup>/<sub>2</sub> of a mile S. from the former, and 3<sup>4</sup>/<sub>2</sub> miles S. from London-bridge, in a situation surrounded by elegant modern villas on the tops of several hills, pleasantly situated in its neighbourhood, seeming to vie with each other in beauty of situation and display of taste, in ornamental villas of the tradesmen of the metropolis, and the pleasure grounds around them; this having also the beautiful grove of Camberwell at a short distance south-easterly, and being itself one of the chief

ornaments to this part of the country, covered with elegant villa residences, some of them splendid mansions; amongst which are those of — Ricardo, Esq., and — Goldsmid, Esq. (splendid mansions), and of — Lawrence, — Davis, — Mousley, — Dearman, — Lee, — Creighton, — Widdows, — Edwards, and — Warren, Esquires.

CHAMPION-HOUSE, a beautiful extensive ancient mansion, situate near Champion-hill, between Camberwell and Crespigny-terrace, 3 miles S. from Londonbridge, with Champion-grove at a small distance, on the easterly side of the Terrace, the property of Sir William de Crespigny, Bart.

CHAPEL-HOUSE, in the parish of Frimley; a handsome small house, the property and lately a temporary residence of James Laurel, Esq. (now of Farnboro'-place, in Farnboro, Hants;) at present unoccupied.

CHAPLANDS-FARM, an excellent farm in the parish of Godstone, 8 miles E.S.E. from Reigate, on the west side of the road from London, through Godstone to Brighton.

CHARLWOOD, a parish in the hundred of Reigate, through part of which passes the road from London, through Reigate to Brighton, the parish lying principally on the right of that road, on the borders of Sussex; being 6½ miles S. S.W. from Reigate, and 28 S. S.W. from London; containing, as per census of 1811, 161 houses, and 959 inhabitants; and as per census of 1821, 1,134 inhabitants. It is a rectory, value 191. 16s. 8d.; patron and incumbent, Rev. H. Wise. This is an extensive parish, wholly agricultural, the land a clayey soil, chiefly occupied by the plough; is of difficult tillage, not very productive, and lets at low rents; and the roads are bad. Here are some woodlands; and this is a part of the wealds or wilds of Surrey, an appellation given to the southerly parts of the county. Here is a residence of *George Dewdney, Esq.* banker, at Dorking.

- CHARLWOOD-HOUSE, a handsome house and extensive farm, in the parish of Charlwood, 6 miles S. from Reigate.
- CHART-FARM, a farm in the parish of Reigate, half-amile E.S.E. from that town.
- CHART-HAM, in the parish of Lingfield, 2 miles S.E. from East-Grinsted, Sussex, and 26 S.S.E. from London; a handsome modern mansion and pleasure grounds, the seat of *G. Boon Roupell*, *Esq.*, barrister at law.
- CHART-LODGE, a modern neat house and a farm, 2<sup>1</sup>/<sub>4</sub> miles E. from Reigate; the property and residence of *Mr. Greece.*
- CHART-PARK, an extensive park on the south-east side of the town of Dorking, in which stood a magnificent mansion of the Duke of Norfolk. The old house is now pulled down; and the park is the property of *T. Hope, Esq.* adjoining to his seat at Deepdene.
- CHATHILL, two extensive farms, at a place so called, in the parish of Tandridge, 8 miles E. from Reigate.

CHEAM, a parish in the hundred of Wallington, 11 mile

E. N. E. from Ewell, and 12 S. S.W. from Londonbridge; containing, by the census of 1811, 130 houses, and 757 inhabitants; and by the census of 1821, 792 inhabitants; situate between the roads from London, through Sutton and Reigate, to Brighton ; and through Ewell and Epsom to Dorking and Guildford, near the Banstead-Downs. In the church is a monument to the memory of Lady Jane Lumley, who died in 1577, and who translated the Iphigenia of Euripides, and some of the Orations of Isocrates into English, as well as one of the latter into Latin. Of six successive rectors of Cheam, from 1581 to 1662, five became bishops. The living is a rectory, value 171. 5s. 5d., in the patronage of St. John's College, Oxford; incumbent, Rev. W. Bennet. This is a genteel neighbourhood, surrounded by the beautiful villages and elegant seats round Ewell and Epsom. Here, in addition to the seats mentioned under their respective titles, are the residences of James Penfold, Esq., Colonel ---- Willard, Miss Peach. ---- Morris, Esq. (the property of Kinnaird Smith, Esq.) W. P. Taunton, Esq. barrister at law (the property of Thomas Harris, Esq.)

CHEAM-ACADEMY, adjoining to the village of Cheam, an extensive boarding-school for gentlemen, conducted by the Rev. James Wilding.

# CHEAM-HOUSE. See LOWER CHEAM-HOUSE.

CHEAM-PARK, an elegant mansion and extensive park, situate in the parish of Cheam, 2 miles N. E. from Ewell, and 11<sup>1</sup>/<sub>2</sub> S. S.W. from London, adjoining to Nonsuch-park, 1<sup>1</sup>/<sub>2</sub> mile W. of the road from London to Reigate and Brighton, the seat of Archdale Palmer, Esq.

- CHEATHURST-FARM, a farm in the parish of Horne, 8 miles S. E. from Reigate.
- CHEESWICK, a farm in the parish of Chiddingfold, 4 miles S. E. from Haslemere.
- CHEESEWICK, a farm in the parish of Horley, 4 miles S.S.E. from Reigate.
- CHELLOWS-FARM, a farm in the parish of Crowhurst, 12 miles E.S.E. from Reigate.
- CHELLOWS-HOUSE, in the parish of Crowhurst; a handsome modern mansion, not very large, with pleasure grounds and plantations, &c. the seat of *James Donovan*, *Esq*.
- CHELSHAM, a hamlet to the parish of Warlingham, hundred of Tandridge, 6 miles S. E. from Croydon, and 16 S. from London-bridge, on the borders of Kent; containing, by the census of 1811, 38 houses, and 237 inhabitants; and by the census of 1821, 217 inhabitants. On Bottle-hill, in the neighbourhood, are the remains of a Roman camp. This hamlet is agricultural, principally arable land, with some wood lands, and is occupied in extensive farms: here some cattle are fed for the London markets, chiefly sheep, on turnips.
- CHELSHAM-COURT, in the hamlet of Chelsham and parish of Warlingham,  $6\frac{1}{2}$  miles S. E. from Croydon, and  $16\frac{1}{2}$  S. from London; a very extensive farm, with a good house, occupied for nearly forty years by Messrs. John and Joseph Willis.

CHELSHAM-LODGE, in the hamlet of Chelsham, 5 miles S.E. from Croydon, and 15 S. from London; a neat dwelling-house, lately erected on Fairchild-farm, the property of *George Smith*, *Esq.* of Selsdon, in the parish of Croydon, at present in the care of a farm servant.

CHEQUERS (The) a farm and inn in the parish of Horley, 41 miles S. from Reigate.

CHERRY-GARDEN, a farm in the parish of Horne, 9 miles S.S. E. from Reigate.

CHERTSEY, or CHERTSEY-BEOMOND, a parish and market town in the hundred of Godley and Chertsey. situated on the south side of the River Thames, 10 miles from Hounslow, in Middlesex, 10 miles W. from Kingston, and 22 W.S.W. from London; containing, by the census of 1811, 659 houses, and 3629 inhabitants, being 1779 males and 1850 females, of whom 191 were returned as being employed in trade, and 334 in agriculture; and in 1821, 4279 inhabitants. There is a handsome bridge over the Thames, built of Portland stone, by Mr. Paine, in 1785, consisting of seven arches. each formed by the segment of a circle, which cost 13,000l. Near to the bridge is one of the locks on the River Thames, by means of which it is made navigable for a considerable distance beyond the flowing of the tide. This has been supposed the spot where Julius Cæsar led the Roman army across the Thames, into the kingdom of Cassivelanus, who had encamped his forces on the opposite shore. The Romans were opposed crossing by stakes driven in the bed of the river, the

banks being fenced with wood ; but these obstacles were surmounted by the Romans. Bede says the stakes were to be seen in the 8th century, being as big as a man's thigh. Here are a commodious workhouse, and an excellent charity school; and here formerly stood an abbey, in which was deposited the corpse of Henry the Sixth, afterwards removed to Windsor. Out of the ruins of the abbey Sir Henry Carew built an elegant mansion in the reign of Charles the Second. In 1773, in digging a vault in the chancel of the church, a leaden coffin was discovered, containing the body of a woman in a high state of preservation; the face was fresh, and the lace of the linen sound. The old church has been taken down, and a new one erected of stone, which is a neat plain structure. In the neighbourhood of St. Ann'shill there formerly stood a chapel of ease. The porch-

house at Chertsey was the retirement of the poet Cowley, where he ended his days, and it now retains the name of Cowley-house (which see.) The town is governed by a bailiff, appointed by letters patent from the exchequer. The market is on Wednesday; fairs, first Monday in Lent for cattle, corn, &c.; May 14th, for sheep, lambs, hops, and toys; August 6th, for black cattle; and 25th September, a statute fair. The living is a rectory, value 13l. 13s. 4d.; patron, Sir J. Mawbey, Bart.; incumbent, Rev. T. E. May. (See St. Ann's-hill, the different seats mentioned by their respective names, and also the list of persons referred to at the end of the work.)

CHESILDEN, a hamlet to the parish of Maldon; population included with Maldon.

CHESNUT-GROVE, in the parish, and near to the town of Kingston, 12 miles S.W. from London-bridge,

lately the seat of Lady Kent; an elegant mansion, the seat of T. W. M. Baskerville, Esq.

CHESSINGTON, a hamlet in the parish of Ewell, hundred of Copthorn, 2 miles W. from Ewell, and 14 S.W. from London; containing, as per census of 1811, 25 houses, and 146 inhabitants; and as per census of 1821, 150 inhabitants. This is a farming district, the land not very productive, chiefly occupied by the plough.

CHESSINGTON-FARM, an extensive farm in the hamlet of Chessington, in the parish of Ewell, 3 miles W. N.W. from the town of Ewell.

CHESSINGTON-HALL, an extensive mansion in the hamlet of Chessington, and parish of Ewell, 2 miles W. from Ewell, and 14 S.W. from London, the seat of *Lieutenant-Colonel Leighton Dalrymple*, companion of the Bath, who distinguished himself in the battle of Waterloo.

CHEVINGTON-FARM, a farm in the parish of Bletchingley, 5<sup>1</sup>/<sub>2</sub> miles E. from the town of Reigate.

CHIDDINGFOLD, a parish in the hundred of Godalming, 4 miles E. N. E. from Haslemere, and 36 S. S.W. from London, on the road from Guildford to Chichester; containing, as per census of 1811, 162 houses, and 933 inhabitants; and as per census of 1821, 909 inhabitants. There were formerly a number of glasshouses here. The living is a rectory, value 261. 4s. 7d. with Haslemere chapel annexed, in the patronage of the Dean and Chapter of Sarum; incumbent, the Rev. Charles Ekins. The inhabitants of this parish are chiefly employed in agriculture. Here is a considerable extent of woodlands, which principally supply the inhabitants with fuel. This is a part of the wealds or wilds of Surrey; but is not so flat as some of the other more easterly parts. In this village are the residences of *William Sadler*, *Esq.*, and *George Burrell*, *Esq.* 

- CHILMEAD-FARM, an extensive farm in the parish of Nutfield, 3 miles E. from Reigate, the residence of *Mrs. Haiglars*; having Brooker's-farm, her property, adjoining.
- CHILWORTH, a hamlet to the parish of St. Nicholas, Guildford, hundred of Woking, 2½ miles E.S.E. from Guildford, and 32 S.S.W. from London. Population included with St. Nicholas. It has a fair seven days before Michaelmas. See ST. MARTHA.
- CHIPSTED, a parish in the hundred of Reigate, on the right of the road from London to Brighton, through Croydon and Reigate, near the Banstead-Downs,  $5\frac{1}{4}$ miles N. N. E. from Reigate, and  $16\frac{1}{2}$  S. from London; containing, as per census in 1811, 55 houses, and 403 inhabitants; and as per census of 1821, 440 inhabitants. It is a rectory, value 17l. 13s.  $11\frac{1}{2}d$ ; patron, the Rev. William Jolliffe; incumbent, Rev. Peter Aubertin. This parish adjoins to the high and beautiful grounds of Gatton, on the hills north of Holmesdale, from which it slopes to the Brighton road, in a valley along which is laid the Surrey iron railway, having a chalky and arid soil, principally cultivated by the plough.

In 1820 Francis Maseres, Esq. cursitor baron of his majesty's court of exchequer, invested 910/. stock in

3 per cent. consolidated bank annuities, upon trusts for payment to the officiating minister of Reigate, 10s. 6d. for every sermon after evening service; and in case of omission, for the purchase of bread, to be distributed amongst poor persons residing in Chipsted, and three other parishes; and 100*l*. like stock, for defraying expenses of the trust. The bread is distributed in pursuance of this bequest.

CHIVELHURST, a farm in the parish of Titsey, 8 miles S. E. from Croydon.

CHOBHAM, a parish in the hundred of Godley and Chertsey, on the south of the Basingstoke canal, 4 miles S.W. from Chertsey, and 22 W. S.W. from London; containing, as per census of 1811, 262 houses, and 1329 inhabitants; and as per census of 1821, 1719 inhabitants. The living is a vicarage, value 101. 2s. 1d.; patrons, the trustees of J. Thornton, Esq.; incumbent, the Rev. Charles Hersham. S.W. from London-bridge, on the road from thence through Reigate to Brighton, which has become one of the most elegant of the villages round London; containing, by the census of 1811, 784 houses, and 5083 inhabitants; and, by the census of 1821, 7151 inhabitants.

The living is a rectory, value 81. 10s.; patron, Henry Forster, Esq.; incumbent, the Rev. Wm. Dealtry, A.B. Clapham Common, on all sides of which are elegant seats, forms an immense square, and though formerly little better than a morass, is now so well planted with various trees, it has more the appearance of a park : and there is almost constantly seen here the passing of carriages and equipages of the genteel residents, in various directions. It is situated partly in the parish of Clapham, and partly in the adjoining parishes of Battersea and Streatham (a small part in the last.) Though there is a regular continuation of modern buildings from hence to the metropolis, yet this spot, the houses being detached from each other, having in general handsome pleasure grounds, with trees and shrubberies around them, is completely rural, and at a distance from town not inconvenient for those of the opulent inhabitants who have retirement here, and who have duties requiring their attendance in parliament, at the bar, or the great mart of commerce. On the northeast corner of the common, near the road to Wandsworth, is a reservoir of fine water, which supplies the parish. A church was erected on the common, in 1776, at the expense of 11,000%, but it has no cemetary. Of the old church, only one aisle is now left standing, in which the funeral service is performed when there are many interments. There is now also a modern church, situate near to the road from Vauxhall to Wandsworth, dedicated to St. Paul. The manor house is rendered conspicuous by a curious octagonal tower.

On the road from Vauxhall to Wandsworth, an elegant mansion, with beautiful pleasure grounds, the residence of William Horne, Esq. In Larkhill-lane, leading from St. Paul's, or the New Church, to Stockwell, leaving Clapham Common on the right, elegant mansions, with lawns and pleasure grounds, of L. A. Goldsmidt, Esg. ; ----- Vernon, Esg., and Thomas Horne, Esg. On Clapham-rise, the approach to Clapham-common from town, are genteel residences, too numerous for insertion, extending to Stockwell, principally of tradesmen in London, of which this may be not improperly considered a part, there being from hence a regular communication of buildings. CLAREMONT, the place selected for the consummation

of earthly bliss, in the counubial happiness of the illustrious personages of His serene Highness Leopold George Frederick, Prince of Saxe Cobourg, and his beloved consort her Royal Highness Charlotte Augusta, Princess of Wales, heiress apparent to the throne of these realms. It was purchased upon the marriage of those illustrious persons for, and became their residence

until the lamentable death of that amiable Princess, in childbed, November 6th, 1817, and hath since continued to be the residence of his Serene Highness. Here are a stately mansion, in an elevated situation, on the east side of a fine vale, through which flows the river Mole; a park, very extensive and beautifully ornamented with fine trees; circuitous walks, &c.; a fine lawn, sloping towards the valley and river; and a fine sheet of water, stored with various sorts of aquatic birds and fish, and the park with game. And on a mount, having the greatest command for prospects, and shaded and tastefully ornamented with trees and shrubs, her late Royal Highness bestowed considerable pains. In an elegant gothic mausoleum are some excellent paintings on glass; without the park there are very extensive plantations. Claremont is distant about half-a-mile E. from the pleasant village of Esher, 4 miles S.S.W. from Kingston, and 14 S.W.

- COULCUTS, a farm in the parish of Tatsfield, 10 miles S. E. from Croydon.
- COULSDON, a parish in the hundred of Wallington, 5 miles S. S.W. from Croydon, and 15 S. from London, between the London roads to Brighton through Reigate and Godstone; containing, by the census of 1811, 81 houses and 440 inhabitants; and by the census of 1821, 516 inhabitants. The living is a rectory, value 21*l*. 16*s*. 5½*d*. patron the Archbishop of Canterbury; incumbent the Rev. J. C. Lockwood, of Croydon. This parish is in a high situation, wholly agricultural; the land on which some sheep are fed on turnips is arable, with some wood lands; let in large farms.
- COULSDON-COURT, in the parish of Coulsdon; a very extensive farm, the residence of Mr. John Fuller.

- COW-MOOR, an extensive tract of common in the parish of Chobham, about 3 miles S.S.E. from Bagshot, no doubt being formerly included as a part of the great extent of barren waste called Bagshot-heath, which is said to have extended much farther eastwardly to Cobham, &c. but of which only some small parts remain unenclosed, interspersed through the country, and those principally enclosed, though not yet cleared from heath.
- COXLAND-FARM, a farm in the parish of Ewhurst; 10 miles S. E. from the town of Guildford.
- CRAB-HILL-FARM, a farm in the parish of Nutfield; 3<sup>1</sup>/<sub>2</sub> miles east from Reigate.
- CRANLEY, a parish in the hundred of Blackheath, on the southerly side of the county, having a great portion of woodlands, 8 miles S. E. from Guildford, and 38 S. S.W. from London; containing, as per census of 1811, 177 houses and 1009 inhabitants; and as per census of 1821, 1182 inhabitants. It is a rectory, value 201. 18s. 1d. Patron Rev. John Wolfe; incumbent Rev. R. B. Wolfe.

the parish of Crowhurst, the property of the trustees of a college at St. Alban's, Herts, with another farm adjoining, 11<sup>1</sup>/<sub>2</sub> miles E. S. E. from Reigate.

CROYDON, a market town and parish in the hundred of Wallington, 10 miles S. from London-bridge; containing, by the census of 1811, 1449 houses, and 7801 inhabitants. of whom 662 families were returned as being employed in trade and manufactures, and 397 in agriculture; total population by the census of 1821, 9254. The church is a spacious and handsome gothic structure, and contains some ancient and fine monuments (one said to be a masterpiece of art) to the memory of the late Archbishops of Canterbury. Here is a hospital for a warden and 28 poor men and women, decayed housekeepers of Croydon and Lambeth, founded by Archbishop Whitgift. The manor has belonged to the Archbishop of Canterbury from the days of William the Conqueror. The Archbishop's palace is now converted into a manufactory. The autumn assizes are holden alternately here and at Guildford. There is a town-hall and sessions-house, in which the assizes are holden. The market is on Saturday. Fairs on the 5th of June and 2d of October; the latter called Walnut Fair, much frequented by the youth of the metropolis. The living is a vicarage, value 211. 18s. 9d. in the patronage of the Archbishop of Canterbury. Incumbent the Rev. J. C. Lockwood. This is a genteel town and neighbourhood, and a considerable thoroughfare, being one of the principal roads to Brighton, and has good inns. In the neighbourhood are kept several packs of fox and stag hounds, and many sportsmen from London, &c. have horses trained and kept hereabouts for the field and turf. This parish abounds with elegant seats and smaller villas, of which the principal are mentioned under their respective names, but there are also, not so mentioned, the residences of the following; namely,-In Coombe-lane, John Keen, Esq.; Samuel Chollett, Esq.; James Bourdien, Esq.; and John Randal, Esq.-In or near Park-lane, H. T. Maubert, Esq.; ---- Crowley, Esq.; Charles Bingham, Esq.; Thomas Meux, Esq. an excellent mansion, purchased from Lord Grosvenor; James Inglis, Esq.; Mr. White; Ralph Lindsey, Esq. Solicitor; Arthur Lewis, Esq. (a very good house); Charles Jelff, Esq.; --- Napp, Esq. - CULMORE, a farm in the parish of Hambledon, near Witley parish; 3½ miles S. S. W. from Godalming.
- CULVERLANDS, a farm near Moor-park, in the parish of Farnham; 1 mile east from that town.
