RANDALL-FARM, a farm near Randall-house, in the parish of Letherhead, 31 miles W.S.W. from Epsom.

- RANDALL-HOUSE, in the parish of Letherhead, 4 miles S. S.W. from Epsom, and 19 S. S.W. from London; a handsome mansion and grounds, in an elegant neighbourhood near the river Mole; the property of Nathaniel Bland, Esq. and the present residence of —— Warre, Esq.
- RANDALLS-FARM, a farm in the parish of Cobham, 6<sup>1</sup>/<sub>2</sub> miles S.W. from Dorking.

RANGER'S-LODGE, in Richmond-park.—See RICH-MOND.

RAVENSBURY-FARM, in the parish of Morden, 81

miles S.S.W. from London-bridge; a handsome house, &c. the residence of *Thomas Merle*, *Esq*.

- **RAVENSBURY-HOUSE**, in the parish of Mitcham, between that village and the pleasant village of Carshalton, near the river Wandle,  $8\frac{1}{2}$  miles S.S.W. from London-bridge; an extensive ancient mansion, with pleasure-grounds and plantations also of great extent; the seat of *Mrs. Bernard*.
- RAY-FARM, a farm partly in the parish of Lingfield, and the remainder in Tandridge; 9 miles E.S.E. from Reigate.
- RAYS, (The) a farm in the parish of Horley, 3<sup>1</sup>/<sub>2</sub> miles S. from Reigate.
- RAYS-FARM, in the parish of Coulsdon, 4 miles S. from Croydon, and 14 S. from London, on the west-side of the road from London, through Croydon and Godstone, to Brighton; a handsome house, with plantations, &c. and a farm, the property and residence of *Robert Lucas*, *Esq*.
- RED-GROUND-FARM, a farm in the parish of Chertsey-Beomond, 2 miles W. from the town.
- RED-HALL-FARM, a farm in the parish of Burstow, 6<sup>1</sup>/<sub>2</sub> miles S.S.E. from Reigate.
- **RED-STONE-HOUSE**, an ancient mansion, now occupied, with an extensive farm, in the parish of Reigate, 2 miles E. from the town.

REDWOOD-FARM, in the parish of Chiddingfold, near Dunsfold, 51 miles S. from Godalming.

REED'S-FARM, a farm in the parish of Lingfield, near the borders of Sussex.

REIGATE, the name of a hundred lying on the southern side of the county, between the hundred of Wootton east, and Tandridge west; of Wallington, and of Copthorn, and Effingham north, and adjoining to Sussex south. [For the parishes contained in this hundred, see the general description of the county, preceding the alphabetical.]

REIGATE, a borough, market-town, and parish in the hundred of Reigate, 6 miles S.S.W. from Croydon, 111 E. from Dorking, and 21 S.S.W. from London, on the road to Brighton; containing, by the census of 1801, 407 houses, and 2246 inhabitants, of whom 234 were returned as being employed in trade. Total population, by the census of 1811, 2240; and of 1821, 2961. The town, which is a great thoroughfare, is seated in a pleasant valley, called Holmesdale, extending from Dorking, in an easterly direction, to the county of Kent, and on a branch of the river Mole. A gate, a cave, and some other small remains are still to be seen of Holmscastle, built by the Earls of Warren, and in which the turbulent barons are said to have held frequent meetings. The castle was forfeited by Lord Monson during the civil wars. In the reign of King William it was granted to Lord Somers. Here was a friary. See the PRIORY. The market-house was formerly a chapel, dedicated to Thomas-a-Becket: it is now also the sessions-house.

The borough has sent two members to parliament ever since the second of Edward I.; the right of election being in the householders of the borough. The town gives title of Baron to the Earl of Peterborough. In the neighbourhood there is fullers-earth. Market on Tuesday. Fairs for cattle first Tuesday in every month, Whit-Monday, and 9th December; and for pedlery, Holy Cross, 14th September. The living is a vicarage, value 201. 5s. 5d.; patroness, Miss Snelson; incumbent, Rev. — Snelson. For an account of a bequest of 10s. 6d. to the minister for every sermon after evening service, see CHIPSTEAD.

Amongst the genteel residences here, besides some mentioned under their respective names, are those of-the. Baron Meseres, a handsome mansion, with beautiful lawn and pleasure-grounds, at the entrance of the town from Croydon and Merstham; ---- Saunders, Esq. a mansion, park and pleasure-grounds, at the same entrance, at a short distance from the road on the right; Miss Saunders; Rev. Robert Snelson, rectory; at the like entrance on the left, a mansion, park, lawn, &c. the property of Miss Fox, in the care of servants: Mr. Glover. In the town, Mr. Ambrose Mansell; Mr. Paley; Mr. Samuel Elcock; a large house of Mr. Robinson, not occupied; Thomas Gale, Esq. banker; Mr. Neale, brewer; Messrs. Piper and Co. bankers; Messrs. Dewdney, bankers; Alexander Broughton, Esg. solicitor; Mrs. Russell; --- Martin, Esq. bailiff of the borough. Entrance from Brighton, at and near Woodhatch, Cockshut-hill, and Park-hill, from which are extensive prospects, the handsome mansion of T. Cherrington, Esq.; Mrs. Jones ; Joseph Fosket, Esq. ; Henry Cherrington, Esq.; ---- Gadderer, Esq.; Mr. John Carter; William Price, Esq.; Peter Dunkerley, Esq.; and

Joseph Nash, jun. Esq. These mansions, and the pleasure-grounds surrounding them, together with their situation, give a charming and ornamental appearance to this neighbourhood.

RETREAT, (The) in the hamlet of Peckham, and parish of Camberwell, in a populous neighbourhood of country villas, 3 miles W. S.W. from London, on the borders of Kent; a handsome seat, with lawn and pleasure-grounds, &c. of William Bousfield, Esq.

**RETREAT**, (The) a handsome mansion, with beautiful shrubberies, lawns, and gardens, situate on the east-side of the town of Reigate, near the church, in a situation to which its name is very appropriate; the seat of *William Turner*, *Esq*.

RETREAT, (The) a handsome mansion, in a situation within walled shrubberies, gardens, &c. (to which the name is appropriate), in the parish of Battersea, on the east-side of the road from the village of Battersea to Clapham-common; the property of —— Hadfield, Esq. lately the residence of —— Alvin, Esq. and the present residence of —— Randall. Esq.

REEVES-FARM, a farm in the parish of Chipsted, 2<sup>1</sup>/<sub>2</sub> miles N. from Reigate.

REYNOLDS-BOOTH, a farm in the parish of Reigate, 11 miles west from the town, near Reigate-heath.

 RICHMOND, a parish in the hundred of Kingston, beautifully situated on the banks of the Thames, 10<sup>3</sup>/<sub>4</sub> miles
 W.S.W. from London. Containing, by the census of

1801, 823 houses, and 4628 inhabitants; of whom 541 were returned as being employed in trades, &c.: population in 1811, 5219; and in 1821, 5994. It was anciently called Sheen, which signifies in Saxon, resplendent, from the beauty of its situation. The royal palace here was long the favourite residence of the British monarchs, but the site is now occupied by private houses, held on lease under the Crown. In the reign of Henry VIII. here were two parks, which appear soon afterwards to have been joined together. The New, or Great Park, being eight miles in circumference, and containing 2253 acres; was made by Charles I. The Great-Lodge, or White-Lodge, was built by Sir Robert Walpole, at the expense of 14,000l. when he was ranger, in the reigns of George I. and II. It is an elegant and extensive mansion, pleasantly situated on an eminence, towards the south-easterly part of the Park; and is the residence of the Right Honourable Lord Viscount Sidmouth .- The Stone-Lodge, sometimes called the Ranger's-Lodge, was built by George I. after a design of the Earl of Pembroke, and is of considerable extent, and now the residence of Sir Henry Campbell, deputy-ranger. - The Thatched-Lodge is situate in a part of the Park which is in the parish of Kingston, and is occupied by Lady Stuart. Nearer to Petersham is the residence of Lady Pembroke. - In 1768, a very commodious Observatory was erected near the Park, by his late Majesty, and furnished with all kinds of astronomical instruments .- Part of the land is now converted into a dairy and grazing farm; and the remainder consists of gardens laid out with great taste, and adorned with many fanciful and grotesque buildings. The banks along the Thames form a noble terrace. (See also KEW.)-The church, which

was repaired and enlarged in 1750, has a square tower and eight bells: at the west end of the north aisle lie the remains of Thomson, the poet, for many years a resident in Kew Foot-lane. There is a brass tablet, with an inscription to his memory, erected by the Earl of Buchan in 1792. Here is also interred the Rev. Gilbert Wakefield .- An elegant stone bridge, of five semicircular arches, was built across the Thames, and finished in 1777 .- In the Vineyard are Queen Elizabeth's Almshouses, which formerly stood under the Hill, for eight poor women. There are also almshouses for ten poor women. On Richmond-hill there are likewise almshouses for ten poor women, endowed by Duppa, Bishop of Winchester, who lived here in a retired manner after the exile of Charles II. At the Marsh-gate are nine almshouses, endowed in 1758 for maiden-women .- The town runs up the Hill above a mile from East-Sheen to the New-Park, with the Royal Gardens sloping to the banks of the Thames. The Green is surrounded by lofty elms, at one corner of which is the Theatre-royal.-The living is a curacy, and was formerly a chapelry to Kingston; patronage the same as Kingston.

Richmond is surrounded by elegant seats and noble mansions, both in this county, and on the opposite bank of the Thames in Middlesex. For a description of some of the beauties and grandeur of the neighbourhood, where it is described with the beautiful winding *silver Thames*, see RICHMOND-HILL.—Here there are, besides the elegant seats and residences mentioned under their respective names, those of the following nobility and gentry, viz.: between Richmond and the Park, near the Park gate, with all the beauties of situation afforded by, and described under the title of, *Richmond-hill*, an ele-

gant and extensive mansion, with beautiful grounds, the seat of Countess Mansfield; an elegant house of Lady Morshead; Mrs. Baker; Joseph Turner, Esg.; Lord Crawford and Lindsey; Mrs. Burn; John May, Esq.; Mrs. Brittingham. On the terrace, Miss Doughty; Mrs. Harrison ; Richard Penn, Esq.; Mrs. Wilson. Below the terrace, Mungo Dick, Esq.; a splendid mansion of the Most Noble the Marquis of Stafford; an extensive mansion, Lady Cardigan ; a gothic house, Mrs. Ellerker ; Duchess of Devonshire ; a magnificent mansion of the benevolent Duchess of Buccleugh. In Paragon-row, fronting the Thames, Lady Ann Bingham; J. B. Brenton, Esq.; Miss Fanshaw. Above the bridge, Samuel Painter, Esq. Below the bridge, fronting the Thames, ---- Smith, Esq. alderman of London; Mrs. Coutts; an ancient seat of the Duke of Queensberry. Old Palace-yard, Lady Sullivan. At the Old Palace, Sir David Dundas. On the Green, Sir William Twisden, an extensive mansion; John Ward, Esq.; the Rev. Dr. Wollaston; an ancient seat of the late Lord Fitzwilliam, not occupied. On the road towards Kew, an elegant house, with extensive pleasure-grounds, ---- Selwyn, Esq. On the road to East-Sheen, the residence of ---- Smith, Esq. colonel of district (the property of the Rev. J. Jeffreys, rector of Barnes); a mansion, the seat of Mrs. Palmer; an extensive and elegant mansion, the property, and late the residence, of Mrs. Abercrombie, the mother of Sir Ralph, and now the residence of the Right Honourable Lord Bishop of Litchfield and Coventry; a mansion and seat of Mrs. Mitchell.

RICHMOND-HILL, a hill delightfully situated between Richmond and Richmond-park, on the south bank of the

"silver Thames," in a neighbourhood abounding with noble mansions and beautiful scenery; presenting,

\_\_\_\_\_" a goodly prospect Of hills and dales," &c.

as described by the Poet Thomson; who, contemplating a time when,

Sacred to sweet retirement, lovers steal,"

to his Amanda thus beautifully sings:

"Which way, Amanda, shall we bend our course? -Say, shall we wind Along the stream? or walk the smiling mead? Or court the forest glades? or wander wild Among the waving harvests? or ascend, While radiant summer opens all its pride, Thy Hill, delightful Shene?\* Here let us sweep The boundless landscape : now the raptur'd eye, Exulting swift, to huge Augusta send; Now to the sister hills that skirt her plain, + To lofty Harrow now, and now to where Majestic Windsor lifts his princely brow. In lovely contrast to this glorious view, Calmly magnificent, then will we turn To where the silver Thames first rural grows : There let the feasted eye unwearied stray; Luxuriant there rove through the pendant woods

Enchanting Vale ! beyond whate'er the muse Has of Achaia or Hesperia sung. O Vale of Bliss! O softly swelling Hills! On which the power of cultivation lies, And joys to see the wonder of his toil. Heavens! what a goodly prospect spreads around, Of hills and dales, and woods and lawns, and spires, And glittering towns, and gilded streams, till all The stretching landscape into smoke decays.

RICHMOND-PARK-FARM, in the parish of Putney, adjoining to Richmond-park, and near to the village of Wimbledon and to Roehampton, 8 miles W. S.W. from London-bridge; a villa summer residence of the Honourable *Mr. Ponsonby*, near to the elegant mansion of his father, the Earl of Besborough, and other elegant seats, with which this neighbourhood abounds.

RICKETS-FARM, a farm in the parish of Charlwood, 5 miles S.W. from Reigate.

- RIDGE-FARM, a farm on the southerly-side of the parish of Capel, adjoining to the borders of Sussex, 7<sup>1</sup>/<sub>2</sub> miles S. from Dorking.
- RIDINGS-FARM, a farm in the parish of Walton-on-Thames, 5 miles W.S.W. from Kingston.
- RIGDENS'-FARM, a farm in the parish of Leigh, 4<sup>1</sup>/<sub>2</sub> miles S.W. from Reigate.
- RIPLEY, a hamlet to the parish of Send, hundred of Woking, on the road from London to Portsmouth, 6 miles N.E. from Guildford. It is a handsome village, and has a chapel of ease. The population was returned included with Send. Here are residences of Admiral Fancourt, a handsome ancient house, with gardens, &c.; small neat house, Captain Elton; a handsome house and gardens, —— Spicer, Esq.; Mrs. M'Trotter; Major Harrison; and backwards, on the left of the road to Guildford, Captain Harrison; Captain Bolton, and Mr. Whitburn; and many other handsome houses.
- RISE-BRIDGE-FARM, a farm in the parish of Reigate, 2 miles west of the town.
- ROARING-HOUSE-FARM, a farm, of which the house is in the parish of Great-Bookham, and a small part of the land; and the remainder in Fetcham; 3½ miles N. N. E. from Dorking.

- ROBIN-HOOD-FARM, a farm in the parish of Kingston, adjoining to Wimbledon-heath, 2<sup>3</sup>/<sub>4</sub> miles E. N. E. from Kingston.
- **ROBINS-HOUSE**, in the village of Tooting,  $6\frac{1}{2}$  miles S.S.W. from London-bridge; a handsome house, the property of —— Rice, Esq. and the present residence of J. M. Vernon, Esq.
- ROCK-FARM, a farm adjoining to Moushill-common, in the parish of Witley, 3 miles S.W. from the town of Godalming.
- RODSALL-FARM, a farm in the parish of Puttenham, 4 miles W. N.W. from Godalming.
- ROEHAMPTON, a hamlet pleasantly situated in the southerly part of the parish of Putney, in an elevated situation near Wimbledon-heath and Richmond-park, abounding with elegant mansions and beautiful pleasuregrounds, being one of the most elegant and pleasant rural situations round London, from which it is distant 8 miles W.S.W. It has a very neat chapel, over the altar of which is an excellent painting of the Lord's Supper. Population included in Putney.

- ROEHAMPTON-GROVE, an extensive modern mansion, with beautiful pleasure-grounds, containing a large fish-pond, situate in the elegant hamlet or village of Roehampton, in the parish of Putney, 9 miles W. S.W.

from Kondon-bridge, the seat of William Gosling, Esq. banker.

- ROEHAMPTON-HOUSE, an elegant mansion, with a beautiful painting in the saloon, of the Pantheon, or feast of the Gods, by Sir James Thornhill, situate in the hamlet of Roehampton and parish of Putney, and near to Wimbledon, 8 miles W. S.W. from London-bridge, surrounded by beautiful grounds, the property of James M'Denton, Esq. formerly the residence of the late Dowager Countess of Kingston, and the present residence of Captain the Hon. — King.
- ROLES-FARM, a farm in the parish of Horley, 7<sup>1</sup>/<sub>2</sub> miles S. S. E. from Reigate.
- **ROOKERY** (The) in the parish, and 2 miles W. S.W. from the town of Dorking, and  $24\frac{3}{4}$  S.S.W. from London, a handsome modern mansion, with lawn, pleasure-grounds, plantations, &c. the residence of *Mrs. Fuller*, widow of the late Richard Fuller, Esq. banker.
- ROOKERY-COTTAGE, in the parish of Putney, in the elegant vicinity of Roehampton and Wimbledon, 8 miles W. S.W. from London-bridge, a neat villa residence of Brymer Belcher, Esq.
- ROOKSNEST, in the parish of Tandridge, three-quarters of a mile east of the road from London, through Croydon and Godstone, to Brighton, 8 miles S. from Croydon, and 18 S. from London, a very elegant mansion, beautifully situated in Holmesdale, amidst fine trees (in which is a rookery) having in its front towards the south, most

beautiful and ornamental pleasure-grounds, and behind the ridge of hills which form the northerly borders of Holmesdale, extending parallel to that valley from near Dorking, to the borders of Kent, being not less romantic here than in other parts, but its steep southerly declivity, on which are round jutting hills of beautiful verdure, being ornamented with numerous hanging woods, forming a pleasing and picturesque appearance, seen at a great distance from a very extensive plain on the south; the seat of *Charles Farmer, Esq.* the present high sheriff of the county.

- ROSE-BANK, a handsome house on the west side of the town of Reigate, the residence of *Mr. Gurnel*.
- ROSE-COTTAGE, in the hamlet of Frimley, in the parish of Ash, the property, and a temporary villa residence of *Colonel White*.
- ROSEDALE-HOUSE, in the parish of and near to Richmond, 4 miles N. from Kingston, and  $10\frac{1}{2}$  W.S.W. from London-bridge, a beautiful seat of the *Dowager* Lady Suffield.
- ROSE-HILL, a handsome mansion, adjoining to the east side of the town of Dorking, the residence of *Richard Lowndes*, *Esq.* barrister at law.
- ROSE-LODGE, near the church in Cobham, a handsome house, the residence of *Thomas James*, *Esq*.

ROSSDALE-HOUSE. See THOMSON'S VILLA.

ROTHERHITHE, a parish in the hundred of Brixton, on the banks of the Thames, sometimes reckoned a part of

the borough of Southwark, 1½ miles east from Londonbridge; containing, by the census of 1801, 1680 houses, and 10,296 inhabitants; viz. 4787 males and 5509 females, of whom 2059 were returned as employed in trade and manufacture, principally in boat-building, shipchandlery, and the various avocations attendant on the navigation of the river Thames. Population in 1811, 12,114, and in 1821, 12,523. Its ancient name was Red-Rose-Haven, and is now frequently called Redriff. The church is a plain building, erected in 1714 by brief and subscription. The living is a rectory, value 18*l*.; in the patronage of Clare-hall, Cambridge; incumbent the Rev. John Short Hewitt.

- ROUGH-BEACH, a farm in the parishes of Horne and Burstow, 6<sup>1</sup>/<sub>2</sub> miles S. E. from Reigate.
- ROUNDABOUT-FARM, a farm in the parish of Charlwood, 4<sup>1</sup>/<sub>2</sub> miles S. S.W. from Reigate.
- ROUNBRIDGE-FARM, a farm in the parish of Woking, 61 miles S. from Chertsey-Beomond.

ROUND-OAK-HOUSE, in the parish of Egham, a handsome modern mansion, situate in a very elegant neighbourhood, on the south-west side of Englefield-green (which is surrounded by beautiful mansions), between Cooper's-hill and Windsor Great-park, 1½ miles W. from Egham, and 21 W. from London, enclosed in beautiful shrubberies, &c. the seat of Thomas Rowden Ward, Esq. a magistrate for the county.

ROUND-TREE-GREEN, detached houses in the parish of West Horsley, 6½ miles E. N. E. from Guildford.

Egham, and 23 S.E. from Windsor, an extensive and elegant modern mansion, with handsome grounds, unoccupied, the property of — Logan, Esq.

- RUSKET-FARM, a farm in a detached part of the parish of Maldon, near Epsom-common, 2<sup>1</sup>/<sub>2</sub> miles W. from Epsom,
- RUSKET'S-FARM, a farm in the parish of Reigate, 1 mile S. from the town, near Earlswood-common.
- RUSS-HILL, several farms, in the parish of Charlwood, 7 miles S. S.W. from Reigate, adjoining to the borders of Sussex.
- RUSSET-PLACE, in the parish of Worplesdon, 3 miles W.S.W. from Guildford.
- RUXLEY-FARM, a farm in the parish of Ewell, 1<sup>1</sup>/<sub>2</sub> miles N. N.W. from that town.
- RUXLEY-LODGE, in the parish of Thames Ditton, 4 miles S. from Kingston, and 16 S.W. from Londonbridge, an elegant mansion, the residence of James Phillips, Esq.
- RYDENS, a neat villa, in the parish of Walton-on-Thames, near to that pleasant village, 5 miles W. from Kingston, lately erected on Ryden's farm, the property and present residence of *Edward Peppin*, *Esq.* a magistrate, lately removed here from his seat of Waltonlodge-park.

SAINT-ANN'S HILL, in the parish of Chertsey, I mile S.W. of the town; a small eminence, nearly circular, commanding most beautiful prospects of the wily meanders of the silver winding Thames, through a flat country, forming opposite to this hill, at a place called Penty-hook, well known in the neighbourhood, the figure of a horse-shoe, commonly called by that name; and of the adjacent country for a considerable distance, being little inferior to Cooper's-hill, the description of which engaged the pen of Sir John Denham. On the east side of this pleasant eminence is a most beautiful mansion, delightfully situated in pleasure-grounds, tastefully ornamented with a great variety of beautiful shrubs and trees, on the gentle ascent to the hill from Egham. The seat of that eminent statesman and patriot, the late Right Honourable Charles James Fox, in his lifetime; and now that of Mrs. Fox.

Near here is a handsome modern villa of *Mr. Wood*; and also Monks-grove (which see).

SAINT-MARTHA, an extra-parochial chapelry, in the hundred of Blackheath, 2 miles E. S. E. from Guildford, and 31 S. S.W. from London; sometimes called Chilworth, from the name of the village or district of Chilworth, which is commensurate with the chapelry. Containing, by the census of 1801, 43 houses, and 112 inhabitants; and by the census of 1821, 197 inhabitants.

The chapel stands very conspicuously alone, on the summit of a round hill. The living donative, not in charge; patron, the proprietor of the Chilworth estate; incumbent, Rev. H. E. Hill.

- SAINT-PIERSE, an extensive farm, in the parish of Lingfield, on the borders of Kent, 5 mile N. N.W. from East-Grinsted.
- SALFORD-MILL and FARM, in the parish of Horley, 23 miles S. E. from Reigate.
- SALMONS GREEN, in the parish of Caterham, 17 miles S. from Croydon, and 17 S. from London; a good dwelling-house, and a farm; the property of Mr. Hinchman.
- SANDERSTEAD, a parish in the hundred of Wallington, 2½ miles S.S.E. from Croydon, and 12½ S. from London. Containing, by the census of 1801, 33 houses, and 204 inhabitants; by the census of 1811, 185; and of 1821, 189 inhabitants. Pleasantly situated on an eminence, commanding delightful views of Croydon and the surrounding neighbourhood. It is a rectory; value, 7*l*. 0s. 6d.; patrons, the trustees of the late Rev. A. W. Wigsell; incumbent, Rev. John Courtney. The church is small and neat, and contains handsome monuments; and here are interred members of respectable families from Croydon and the neighbourhood.

SANDERSTEAD-COURT, situate near the church, in the parish of Sanderstead, 2½ miles S.S.E. from Croydon, and 12½ S. from London; an anciet handsome brick-built mansion, on a valuable glebe estate of that parish. Late rectors, the Rev. Thomas Wigsell, and the Rev. Atwood Wigsell; the latter of whom has left an infant son: present rector, the Rev. John Courtney. This mansion is the present residence, of <u>Ben-</u> son, Esq.

- SANDGATE, in the parish of Chertsey-Beomond, halfa-mile S. from that town, towards Botley's-park, on the road to Guildford; a handsome mansion, with pleasuregrounds and plantations; the seat of *Francis Whitewick*, *Esq.* a magistrate of the county.
- SANDOWN-FARM, a farm in the parish of Esher, 3<sup>1</sup>/<sub>2</sub> miles S.W. from Kingston.
- SAN-PLACE, a handsome house, adjoining to the westerly side of the town of Dorking; the residence of *Hugh Bishop*, *Esq*.
- SANTON, a good house, with some land, in the parish of Reigate, 2 miles W. from the town.
- SANTON-FARM, a farm 1<sup>1</sup>/<sub>2</sub> miles W. from the town of Reigate.
- SATTENHAM, a farm in the parish of Witley, 2 miles S.S.W. from Godalming.
- SAYES, in the parish of Chertsey, 1<sup>2</sup>/<sub>4</sub> miles S. from the town, and 2 W. from Weybridge; an ancient extensive mansion, with park and plantations; the property of the Crown; formerly the seat of — Payne, Esq. now unoccupied.

SCOTLAND-FARM, a farm in the parish of Albury, near Knoll-hill, 4½ miles E. from Guildford.

SCOTLAND-FARM, a farm in the parish of Bramley, 6 miles S. from Guildford.

SEAL, a parish in the hundred of Farnham, situate in a valley, on the south of the road from Guildford to Farnham, and the range of chalk-hills called the Hog's-back, 3½ miles E. from Farnham, and 35 S.S.W. from London. Containing, by the census of 1801, 203 houses, and 333 inhabitants; by the census of 1811, 360; and of 1821, 364 inhabitants. The living is a curacy; patron and incumbent, Rev. C. Cooke. Near the church here is a handsome residence of John Wood, Esq.

SELSDON, pleasantly situated in the detached part of the parish of Croydon, at its south-easterly extremity, near Sanderstead church, 3 miles S. S. E. from that town, and 133 S. from London; on an elevation commanding prospects over a considerable extent of country, in which are many elegant seats, variously dispersed; a spacious elegant mansion, with extensive grounds and plantations; the seat of *George Smith*, *Esq*.

SEND, a parish in the hundred of Woking, 4 miles N. N. E. from Guildford, and 26 S.W. from London. Containing, by the census of 1801, 191 houses, and 1024 inhabitants; by the census of 1811, 990; and of 1821, 1283 inhabitants: including the hamlet of Ripley. It is a vicarage; value, 8l. 18s. 1d. with Ripley chapel annexed; patron, Earl of Onslow; incumbent, Rev. G. W. Onslow.—In this parish, and the hamlet of Ripley, are several elegant seats; and on the north-west side of

the parish flows the river Wey, through an extensive flat space of fine meadows, with grounds diverging to eminences on the sides, near which are extensive parks, &c.

- SEND-BARNS, in the parish of Send, on the west side of the road from Kingston to Guildford, 4 miles N. E. from Guildford; a handsome ancient extensive house, and a farm; the residence of *Mr. Whittington*, landsteward of Lord Onslow.
- SEND-GROVE, in the parish of Send; a handsome modern mansion, situate near the church, 4 miles N. N. E. from Guildford, with an extensive park, on the west or south-west side of which flows the river Wey, through an extensive flat of fine meadows, adjoining to the Park of Sutton-place, which is a gentle eminence about a mile distant to the south-west; the stately trees of which, and of this park, are very ornamental to this beautiful situation; which was formerly the seat of Admiral Sir Francis Drake; afterwards of General Evelyn; lately of A. Onslow, Esq. M. P. King's sergeant; and now of *Captain Bowles*.
- SHABDON-HOUSE (or GREAT-SHABDON), pleasantly situated in an elevated situation, in the parish of Chipsted, being on the northerly declivity of a range of hills on the north of Holmesdale; 4 miles N. from Reigate, 6½ S.S.W. from Croydon, and 16½ S.S.W. from London: an extensive mansion; the seat of Archibald Little, Esq.
- SHALFORD (including the hamlets of East and West Shalford), a parish in the hundred of Blackheath, 1 mile S. from Guildford. Containing, by the census of 1801

113 houses, and 634 inhabitants; by the census of 1811, 620; and by the census of 1821, 744 inhabitants.—The living is a rectory; value, 8*l*. 4s. 7*d*.; in the patronage of the King; incumbent, Rev. G. W. Onslow.

This parish is situated on the river Wey, in the valley between Guildford and Godalming, which is a fine valley, flat in the middle, with hills and hanging woods on each side.

On Shalford-common is a handsome house of Mrs. Gibson.

SHALFORD-HOUSE, in the parish of Shalford, 1 mile N. from Guildford; a very handsome and very large mansion, pleasantly situated on the river Wey, in the fine valley on the east side of the road from Guildford to Godalming, near St. Catherine's-hill, on which is a beautiful ruin, and where is annually holden a fair. The property of Edmund Austin, Esq. and the present residence of James Ladbroke Weller, Esq. son of Dr. Weller.

SHAW-BARN-FARM, a farm in the parish of Woking, 61 miles N.N.E. from Guildford.

SHAWS-FARM, an extensive farm, on the boundary of the parishes of Tandridge and Godstone, 11 miles S. E. from Reigate; in the occupation of *Mr. Danid Anscomb*, in whose family it has remained for two centuries past.

SHEEP-BELL-FARM, an extensive farm, in the parish of Great-Bookham, 2 miles N. N.W. from Letherhead.

SHEEP-LEAS, in West-Horsley.— See West-Hors-LEY-PLACE. SHERE (or SHIERE), a parish in the hundred of Blackheath, between Guildford and Dorking, 5 miles E. from the former, and 7 W. from the latter, and 30 S.S.W. from London. Containing, by the census of 1801, 183 houses, and 171 inhabitants; by the census of 1811, 918; and of 1821, 1077 inhabitants. A reason is assigned for the increase of population: that married men being sure of employment in preference to single men, or of obtaining relief if unemployed, early marriages are become usual at Shere .- The living is a rectory; value, 261. 1s. 5d.; by lapse in the patronage of the Bishop of Winton; incumbent, Rev. J. Duncomb.-This village is bounded on the north by a commanding eminence, rendered beautiful by the park and extensive plantations of Netley-place, and is situated in a valley, through which runs a fine stream of water, well stored with fish, amongst which are trout; and adjoins westwardly to the pleasant village of Albury; a neighbourhood rendered beautiful by natural scenery and elegant seats, with parks, &c.

- SHERE-COTTAGE, a neat romantic villa residence in Shere, embosomed in evergreens; the seat of the Baroness De Role, sister of Mrs. Lomax, of Netley-place.
- SHIRLEY-LODGE, in the parish, 2 miles eastward from the town of Croydon, near the borders of Kent, and 12
  S.S.E. from London; an elegant seat of Samuel Lloyd, Esq. banker.
- SHERWOOD LODGE, an elegant house, delightfully situated in beautiful gardens fronting the Thames, in the parish of Battersea, half-a-mile S.W. from the church, on the right of the lower road from Vauxhall to Wandsworth; the residence of *Mrs. Fitzherbert*.

- SIMON'S-CROSS, a handsome house, in the parish of Reigate, 1 mile S. from that town, on the left of the road to Brighton; the property and residence of —— Bennett, Esg.
- SIMPLE-MARSH-FARM, a farm in the parish of Chertsey-Beomond, 1<sup>1</sup>/<sub>2</sub> miles S. from the town.
- SKAPELLS, an extensive farm, in the parish of Albury, 5½ miles S. E. from Guildford.
- SLINES OAKS (or SLINES HILL), a handsome house, with plantations, &c. situate on an eminence, in the parish of Woldingham, 5 miles E. N.E. from Godstone, and 6 S.E. from Croydon; the residence of E. T. Beynon, Esq.
- SLYFORD-MILL-FARM (with the MILL), a farm in the parish of Great-Bookham, 2<sup>1</sup>/<sub>2</sub> miles W.S.W. from Letherhead.
- SMALL-FIELD-FARM, a farm in the parish of Burstow, 6<sup>1</sup>/<sub>2</sub> miles S. E. from Reigate.
- SMALL-FIELD-PLACE, an extensive mansion, very ancient, with an extensive farm, in the parish of Burstow, 6<sup>1</sup>/<sub>2</sub> miles S. E. from Reigate.
- SMITHERS-FARM, a farm in the parish of Lingfield, 3<sup>1</sup>/<sub>2</sub> miles E. N. E. from East-Grinsted.
- SNAILLAMS-FARM, a handsome house, with plantations, &c. and a farm, in the parish of Bramley, 3½ miles S. from Guildford.

SHIRLEY-HOUSE, an elegant mansion, with extensive grounds and plantations; in a genteel neighbourhood, where there are many elegant seats; in the parish, and 1<sup>4</sup>/<sub>2</sub> miles eastward from the town, of Croydon, towards the borders of Kent, and 11<sup>4</sup>/<sub>2</sub> S.S.E. from London; the seat of John Maberley, Esq. M.P.

- SHOELAND-FARM, a farm in the parish of Puttenham, on the north side of the Hogs-back, 4<sup>1</sup>/<sub>2</sub> miles E. from Farnham.
- SHRUB-HILL, a handsome mansion, on the left at the entrance of the town of Dorking (from London), with very beautiful gardens, shrubberies, &c.; the residence of the *Countess of Rothes*.
- SICKLE-MILL, in the parish of Frensham, adjoining to Hampshire, 11 miles S.W. from Haslemere.
- SIDLOW-MILL, and a farm, in the parish of Horley, 2 miles S. from Reigate.
- SIDNEY-FARM, a farm in the parish of Aldfold, adjoining to Sussex, 8<sup>1</sup>/<sub>2</sub> miles S.S.E. from Godalming.

SOUTHBOROUGH-HOUSE, in the parish of Kingston, 2 miles S. from the town, and 14 S.W. from London-bridge, an elegant mansion, the seat of *Thomas Langley*, *Esq*.

SOUTHERN-FARM, a farm in the parish of Chipsted, 61 miles S. S. E. from Ewell.

SOUTH-HALE, an extensive farm, in the parish of Nutfield, 4<sup>1</sup>/<sub>2</sub> miles S. from Reigate.

SOUTH-HOUSE, in the parish of Oxted, 9 miles E. from Reigate, a handsome villa residence of — Talboy, Esq.

SOUTH-LAMBETH. See LAMBETH.

SOUTHLAND, a farm in the detached part of the parish of Wootton, adjoining to Sussex, 9 miles S.W. from Dorking.

SOUTH-LANDS, a farm in the parish of Leigh, 2<sup>1</sup>/<sub>2</sub> miles S.W. from Reigate. SOUTHWARK, a borough in the suburbs of the city of London, on the south side of the Thames, over which are here London and Southwark bridges. The former of great antiquity, the latter of cast-iron, completed in 1820, at an estimate of 287,0001. For the better accommodation of passengers, as well as with a view to avoid accidents on the river Thames, frequently occasioned by the rapid current of the water through the narrow arches of London-bridge, in consequence of the water being confined by the numerous broad piers, between them, a new bridge is about to be erected; which public benefit the British Parliament sanctioned, not only by an Act passed on the 2d of June in the present year, but by the supply of efficient means for accomplishing the design from the Treasury, in aid of the funds of the city of London; which, with the Waterloo-bridge, in the Strand, finished in 1815, by subscription, of 1,000,000l. added to those of Blackfriars, finished in the year 1769, Westminsterbridge built between 1730 and 1750, at an expense of 389,5001. and Vauxhall-bridge, which cost 300,0001. afford a most convenient communication from the circumjacent parts of this county with the great cities of London and Westminster, and are grand and beautiful objects, highly ornamental, and indicative of the immense wealth and concourse of the great metropolis, of which the borough of Southwark, now under description, forms no inconsiderable portion. This borough is improving in population and appearance, more particularly on the outskirts, and within a short distance, where the increase of modern erections is of an almost incredible extent, and most of the spaces which were vacant within the borough are now occupied, and the borough itself is encompassed by buildings for several miles in extent. It contains six parishes, viz. St. George's; Christ Church; St. John's,

Horsleydown; St. Olave's; St. Saviour's; and St. Thomas's; and, by the census of 1801, 10,933 houses and 67,488 inhabitants, viz. 31,704 males, and 35,744 females, of whom 13,057 were employed in trade. Total population in 1811, 71,255; and, in 1821, 85,905. There is a great commercial traffic here, having amongst its various branches a very extensive one for hops, and one for sheep's wool.

Southwark appears to have had a distinct corporation prior to 1327. It was then annexed to the city of London, and the Mayor of London was appointed bailiff for the borough. Afterwards it regained its ancient privileges, and was again annexed to the city: in the reign of Edward the Sixth, for the sum of 500 marks paid to the crown by the corporation of London, it was made one of the city wards, by the name of Bridge-ward-without. The Lord Mayor has under him a steward and bailiff, and the government is in one of the 26 aldermen. The steward holds a court at St. Margaret's-hill every Monday, for the recovery of debts, and for damages and trespasses within his limits. The military government is under the Lord Lieutenant of the county. The principal street is that called the Borough High-street, commencing at London-bridge, and running south to St. Margaret'shill. This part of the street is narrow and confined. Many of its buildings on each side exhibit the architecture of past ages. From St. Margaret's-hill to its extremity at the stones-end, being the extent of the borough, the street is much wider, continuing nearly in a line past St. George's church. Tooley-street is of considerable length, running parallel to the river, eastwardly from the end of High-street, near London-bridge, and is accounted a principal street, but it is narrow, and in the winter dirty, the Borough having in general the disadvan-

tage of rather a low flat situation. Some of the churches and the public and charitable institutions are highly creditable to the liberality and beneficence of their founders. Near the foot of London-bridge and the entrance of Tooley-street, is St. Olave's church, erected in 1739, having a plain body, strengthened with rustic coins. The tower, consisting of three stages (the uppermost greatly diminished) is surrounded at the top by a strong balustrade. Near this church formerly stood the city residence of the Abbot of St. Augustine's in Canterbury, the site of which is now a wharf; also the mansion of the Abbot of Battle in Sussex, the site of which is now called Battle-bridge, having on the south spacious gardens, in which was a labyrinth or maze, the name being still preserved in Maze-pond, the names of the streets built thereon. Near London-bridge, in a back situation, on the west-side of the High-street, is St. Saviour's church, a noble gothic structure, in the form of a cathedral, and the largest parish church in the kingdom, anciently called St. Mary Overy's, which was originally founded by a woman, who acquired considerable riches by a ferry over the Thames, before the erection of London-bridge: that part now called Bankside was noted for its brothels, publicly licensed under the Bishop of Winchester, having a parish attached to its district, called the Clink. Near this church is the Borough-market for provisions, principally vegetables. In the High-street is St. Thomas's Hospital, instituted by Edward VI. and the parish church of St. Thomas, originally erected as a chapel for the hospital, and which adjoin to each other, and which is an impropriation in the gift of its governors, who chuse one of two returned by the parishioners. On the opposite side of St. Thomas's-street, is Guy's Hospital. of two quadrangles, founded by Thomas Guy, a citizen of

London, for the relief of the poor sick and lame. At the corner of Kent-street stands St. George's church, a fine building, with a spire. A little more southerly is the King's Bench prison, for the confinement of debtors and others committed here by the Court of King's Bench, which is an extensive plain building, in a yard, surrounded by a high wall. In Horesemonger-lane is a handsome Sessions-house, and a gaol for the county. Here are several almshouses and charitable institutions.

The parish of St. George is a rectory, rated at 181. 13s. 9d. in the patronage of the King; incumbent the Rev. John Buckland. St. Olave's, also a rectory, value 681. 4s. 9<sup>1</sup>/<sub>2</sub>d.; patron the King; incumbent Rev. William Green. St. Saviour's, a curacy, value 2001.; in the patronage of the parishioners in a select vestry; incumbent Rev. H. Harrison, D. D. St. Thomas's, a curacy, not in charge, in the patronage of the Governors of St. Thomas's Hospital; incumbent Rev. C. S. Hodgkin. Christ Church a rectory, not charged in the King's books; patron H. Toulman, Esq.; incumbent Rev. J. H. Mapleton. And St. John's, Horsleydown, a rectory, in the patronage of the King, value 191. 15s. 7d.; incumbent Rev. W. J. Abdy.

SPARROW-FARM, a farm in the parish of Cuddington, 1 mile N. from Ewell.

SPARROW-HALL, in the parish of, and adjoining to, the village of Streatham, 6 miles S. from Londonbridge; a small neat modern house, the residence of *H. T. Gibson, Esq.* 

SPEARS, a farm in the parish of Horley, 5<sup>1</sup>/<sub>2</sub> miles S.S.E. from Reigate.

SPITAL-FARM, in the parish of Morden, 9<sup>1</sup>/<sub>2</sub> miles S. S.W. from London; a handsome mansion, with beautiful grounds, and a farm, the property and residence of *George Matthew Hoare*, *Esq.* banker.

SPRING-FARM, a farm in the parish of Dorking, 3 miles S.W. from Dorking.

SPRINGFIELD-COTTAGE, in the hamlet of Dulwich, and parish of Camberwell, on the south-side of Dulwich, towards Brockwell-hall, 5<sup>1</sup>/<sub>2</sub> miles S. from London-bridge; a handsome cottage residence of —— Spencer, Esq.

SPRING-FIELD-FARM, situate in the parish of Wandsworth, on the west-side of Wandsworth-common, 6½ miles S.W. from London-bridge; with handsome modern mansion, and other erections, the residence of *H. Perkins, Esq.* 

- SPRING-FIELD-LODGE, a handsome modern gothic villa, pleasantly situated at the foot of Box-hill, on the river Mole, in the valley between Mickleham and Dorking, 1 mile N. from the latter; the property of Miss Singer, and the present residence of — Savage, Esq.
- SPRING-GROVE, in the parish of Richmond, near to Eastsheen, half-a-mile E. from Richmond, and 10 W.S.W. from London-bridge, and also near Richmond-hill (which see); an elegant mansion, with handsome pleasuregrounds, the seat of the *Dowager Lady Price*.
- SPRING-PARK, in the parish of Addington, 2<sup>1</sup>/<sub>2</sub> miles E. from Croydon, and 12<sup>1</sup>/<sub>2</sub> S. from London, near the

borders of Kent; a handsome mansion, the property of John Maberley, Esq. M. P. and the present residence of —— Taylor, Esq.

SPRING-WELL, an elegant mansion, with lawn, shrubberies, &c.; the seat of John Shewel, Esq. situated on Clapham-common.—See CLAPHAM.

STAGBURY-HALL, in the parish of Woodmanstern, 5<sup>1</sup>/<sub>2</sub> miles N. N. E. from Reigate, 6 S.W. from Croydon, and 16 S. S.W. from London; the seat of the Honourable Thomas Walpole.

STANDINGS-FARM, a farm in the parish, and half-amile N. from the town of Reigate.

STANFORD-COTTAGE, a handsome house, in the cottage style, in the parish of Epsom, near that town, 15 miles S.S.W. from London; the seat of John Richardson, Esq.

STANNERS-HILL-FARM, a farm in the parish of Chobham, 3<sup>1</sup>/<sub>2</sub> miles W. S.W. from the town of Chertsey-Beomond.

STANTON-FARM, a farm in the parish of Godstone, 6 miles E. from Reigate.

STAPLES HILL, on a large tract of common in the parish of Chobham, between Chertsey-Beomond and Bagshot, about 4½ miles from each, and no doubt being a part formerly of the great extent of heath called Bagshot-heath, which extended as far eastwardly as Cobham, but of which this, and a few other tracts only, now remain unenclosed.

STARBOROUGH-CASTLE, in the parish of Lingfield, 5<sup>1</sup>/<sub>3</sub> miles N.E. from East-Grinsted, Sussex, and 27 S.S.E. from London; an elegant and spacious mansion, and an extensive park, the seat of *Christopher Smith*, *Esq.* alderman, and late Lord Mayor of London, who is the owner and occupier of farms here of very considerable extent.

STOCKENDEN-FARM, in the parish of Limpsfield, on the borders of Kent, 11<sup>1</sup>/<sub>2</sub> miles E. from Reigate.

STOCK-HOUSE, an extensive farm, in the parish of Oxted,  $9\frac{1}{2}$  miles E. from Reigate.

STOCKRIDEN-FARM, a farm in the northerly part of the parish of Capel, 4 miles S.S.E. from Dorking.

STOCKS-FARM, a farm in the parish of Mitcham, 2<sup>1</sup>/<sub>2</sub> miles N.W. from Croydon.

STOCKWELL, a hamlet in the parish of Lambeth, in the hundred of Brixton, 2 miles S. E. from Westminster-bridge. Population included in Lambeth. Here is a chapel of ease, which was erected in 1767; incumbent, rector of Lambeth. This is an elegant neighbourhood, pleasantly situated on a very gentle ascent, towards Clapham; which hath attracted so great a number of the inhabitants from the metropolis, to erect mansions, that it has become almost joined to it: many of the modern erections, however, generally, have the advantages of country houses, being detached and interspersed in a

variety of situations, with open spaces around them, and various lawns and pleasure-grounds, which, with the elegant and modern structure of the houses, have a very pleasant appearance. STOCKWELL-LODGE, a handsome mansion, with pleasure-grounds, &c. pleasantly situated between the village of Stockwell and Clapham, 3 miles S. from London-bridge; the residence of the *Rev. John Simpson* Surgrove.

STOCKWELL-PLACE, a handsome mansion, situated between the village of Stockwell, or Stockwell-green, and Stockwell-common, or the Clapham-road, 3 miles S. from London-bridge; the residence of *Richard Guyllim, Esq.* 

STOKE (or STOKE, nigh Guildford,) a parish in the hundred of Woking, 1 mile N. from Guildford, and 31 S.S.W. from London; containing, by the census of 1801, 135 houses, and 788 inhabitants; by the census of 1811, 942; and of 1821, 1120 inhabitants. The living is a rectory, of the clear value of 20*l*. when certified, for the benefit of the augmentation acts.

This parish is pleasantly situated on the river Wey, in a fine valley, in which are elegant seats, and beautiful grounds. The seats are described under their respective names.
